

**5 Day Plus Non-Voting Member
Terms and Conditions 2019**

1. The member shall be a 5 Day Plus Non-Voting Member (hereinafter referred to as a “Member”) of the Club as defined by clause 11 of the Constitution and Rules.
2. The Member shall pay an annual subscription, which shall be inclusive of the G.U.I / I.L.G.U. fee, development levy, Golfer’s Insurance and a Bar/Restaurant prepayment as set out below.
3. Normal payment arrangements, as directed by the Honorary Secretary of the Joint Club, will apply.
4. This scheme of membership is for 12 months only terminating on 31st December 2029, with no commitment to renewal or continuation of the scheme and the Member acknowledges that he/she has no expectation relating to 5 Day Plus membership retention.
5. The Member shall be entitled to book and play Corrstown golf courses, when open and subject to tee time availability, as follows:
 - A combination of the 27 holes may be booked to play at all times from Monday to Friday (excluding Public Holidays).
 - The Spare Nine golf course of the day may be booked to play at all times on Saturdays, Sundays and Public Holidays.
 - The competition nines (not spare nine) golf courses may be booked to play outside competition times on Saturdays, Sundays and Public Holidays as a casual golfer, subject to payment of a green fee at the member guest rate.
6. The Member shall have priority over non-members to make an application for election as a full voting member. The appropriate fees (if any), levies (if any) and additional Annual Subscription payable shall be fixed by the Committee of Management.
7. A member may not change member category to 5 Day Plus Non-Voting Member within 3 years of a previous change of category.
8. This membership is non-transferable and a Member may not appoint a nominee in their place as a playing member.
9. The Member shall be entitled, subject to GUI / ILGU regulations, to represent Corrstown Golf Club in inter-club competitions on payment of the appropriate fee as fixed by Committee of Management.
10. The Member shall not be entitled to enter Club weekend and Public Holiday competitions.
11. Entry to appropriate Mon – Fri competitions may be provided for the Member at the discretion of the appropriate club i.e. Ladies Club or Men’s Club. The Member will not be entitled to guest privileges for Club competitions.
12. The Member will have no right to attend or vote at any meetings held by the Joint Club either ordinary or extraordinary.
13. The Member will have no right to be elected to or co-opted to be a member of any committee or subcommittee of the Ladies/Men’s or Joint Clubs.
14. I agree to these terms and conditions and to the conditions of membership as set out in the Constitution and Rules, Special Regulations and the Rules and Bye-Laws of Corrstown Golf Club and its respective Clubs as apply from time to time. I also recognise that a failure on my part to comply with the terms and conditions governing my membership could lead to the suspension of my playing rights or my expulsion from the Club.
